### Sprinkling Credit

A sprinkling credit for summer usage is based on the average winter usage. A sprinkling credit will be granted when the summer usage exceeds the winter average. This is a reduction in the charge for sewerage service and is shown separately on the water bill. Sprinkling credits are applied to City residential customers only.

**Seasonal, Emergency, or Temporary Service PSC (Mgt-1)**

Seasonal customers\* shall pay an annual seasonal service charge equal to twelve times the applicable monthly service charge or six times the applicable bi-monthly service charge in Schedule Mg-1. Water use in any billing period shall be billed at the applicable volume rates in Schedule Mg-1 and the charge added to the annual seasonal service charge. Further, if service has been disconnected or a meter removed, a charge under Schedule R-1 shall be applied at the time of reconnection or meter reinstallation.

\*Seasonal customers are general service customers whose use of water is normally for recurring periods of less than a year.
